ROCKY BRINKLEY SPEAKS ON ADMINISTRATION

MC students returned from their Christmas vacation to find their campus overrun with police. Everywhere they went they were confronted by uniformed guards. In a press release issued by the administration it was stated that this action was taken because many students were exemplifing conduct unbecoming a MC student. No one particular incident caused this action but rather many. The fact that a member of the safey patrol was run over in a parking lot rumble was one such incident. Another was an act of grand larcency committed by 15 students as they held up the Library for money received in fines and the theft of 20,000 editions from he same building. Still another was the riot in the New Great Cafeteria concerning 500 students trying to get food from he kitchen.




